Related to Going Concern

We draw attention to the Note 15 to the financial statement which indicates that The Company has incurred net loss of INR 50.90 lakh during the year ended 31st March, 2020 , however as per decision of the management the financial statement have been prepared on a going concern basis. Our opinion is not modified in respect of the said matter.

Management's Responsibility for the Financial Statements
