Dear Sir/Madam,

In furtherance to the earlier intimation dated 11th September, 2024 made by the Company for entering into MOU to acquire a Rubber Recycling plant in Europe by step down subsidiary of the Company and pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure requirements) Regulations, 2015, we wish to inform you that said acquisition is completed by forming a separate SPV in Romania in which step down subsidiary of company Gravita Netherlands BV (herein after "GNBV") is holding 80% of equity with management control in the said SPV and remaining equity holds by other partners based in Romania.

Further, total investment in this transaction is approx. Rs. 40 Cr. and GNBV has invested approx. Rs. 32 Cr. towards its contribution to acquire the said Waste Tyre Recycling plant in Romania having a capacity of approx. 18,000 MTPA.

The details for the above acquisition (as required to be furnished pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations and SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13 July 2023) were already disclosed in our intimation letter dated 11th September, 2024.
