Details of the violation(s) / contravention(s) committed or alleged to be committed	It is submitted that the GST Authorities have initiated investigation against one of our vendors, M/s RST Batteries, on the allegation that the said vendor has issued invoices in contravention of the provisions of Section 16 of the Central Goods and Services Tax Act, 2017. On this basis, the Department has directed reversal of the Input Tax Credit so availed, along with imposition of penalty under Section 74 of the CGST Act, 2017. We respectfully submit that an appeal was filed before the Appellate Authority under the CGST Act, along with all relevant documentary evidence substantiating that the invoices in question were duly accompanied by actual receipt of goods. However, without due consideration of the documents placed on record, the Appellate Authority has rejected our appeal. Being aggrieved by the said order, we propose to prefer a further appeal before the Goods and Services Tax Appellate Tribunal (GSTAT) within the limitation period prescribed under Section 112 of the CGST Act, 2017.
